Europe's most ambitious innovation initiative

- €10 billion programme to identify, develop and scale up breakthrough technologies and disruptive innovations in Europe
- **Unique** in the world to combine research on emerging technologies with Accelerator for startups, SMEs and scaleups
- EIC set to become **largest deep-tech investor** in Europe (over €3 billion)
- Enhances the European innovation ecosystem (partnerships with EIT, ERC, etc)
- First work Programme adopted 18 March 2021, €1.5 billion
- Second Work Programme adopted 7 February 2022, €1.7 billion



EIC main instruments and characteristics

Pathfinder (TRL1-4)

- For consortia
- Early stage research on breakthrough technologies
- Grants up to €3/4 million

Transition (TRL 4-6)

- For consortia and single entities
- Technology maturation from proof of concept to validation
- Business & market readiness
- Grants up to €2.5 million

Accelerator (TRL 6-9)

- For individual SMEs
- Development & scale up of deep-tech/ disruptive innovations by startups/ SMEs
- Blended finance (grants up to €2.5 million; equity investment up to €15 million or above)

- Focus on breakthrough, market-creating, deep-tech
- Mainly bottom up complemented by targeted funding on strategic technologies/ challenges
- Steered by **EIC Board** of leading innovators (entrepreneurs, investors, researchers, ecosystem)
- Business Acceleration Services (coaches/ mentors, corporates, investors, ecosystem)
- **Pro-active management** (roadmaps, reviews, re-orientations, etc) with EIC Programme Managers
- **Fast track access** to Accelerator for results from EIT, EIC Pathfinder,

Establishment of EIC Board

- Appointed on 18 November 2021 for 2 year mandate
- Role to advise:
 - EIC strategy,
 - EIC work programme & implementation
 - Broader innovation policy
- Diverse expertise:
 - Entrepreneurs, investors, researchers, innovation ecosystem
 - Gender balance (parity), Geographic balance (20 nationalities)
- First meeting on 26 November
- EIC Board Statement to welcome Work
 Programme published 9 February



EIC Pathfinder 2021



- Successful completion of the first Pathfinder Open evaluation (56 proposals retained for funding)
- Implementation of the first rebuttal ('right-to-react') pilot under Horizon Europe
- Successful launch of five Pathfinder Challenges (in total 433 proposals submitted, evaluation ongoing)

EIC Work Programme 2022 - overview

- Budget: €1.69 billion
 - EIC Pathfinder: €350 million (+€50m)
 - EIC Transition: €131 million (+€31m)
 - EIC Accelerator: €1.16 billion (+€70m)
- Strong continuity for main calls
- Some simplifications and improvements in application process
- Evolution of EIC challenges

Simplifications and improvements in main calls

- EIC Pathfinder
 - Improved **rebuttal procedure** (clearer timelines)
- EIC Transition
 - Clarifications on **eligibility of consortia**
- EIC Accelerator
 - **Improved resubmissions** (evaluators to take account of improvements and rebuttals following first evaluation)
 - **Simplified Seal of Excellence** (awarded to all companies attending jury interview*) to help obtain funding from Structural Funds, Recovery Funds, national/regional programmes or other sources.

^{*} Applicants must give consent to share date with other funders; in exceptional cases juries can decide against award of Seal of Excellence



Evolution of EIC Challenges

• €167 million for six Pathfinder Challenges:

- Carbon dioxide & nitrogen management and valorisation;
- Mid-long term, systems-integrated energy storage;
- Cardiogenomics;
- Healthcare continuum technologies;
- DNA-based digital data storage;
- Aternative quantum information processing, communication, and sensing

• €60.5 million for three Transition Challenges:

- Green digital devices for the future;
- Process and system integration of clean energy technologies;
- RNA-based therapies and diagnostics for complex or rare genetic diseases

€537 million for two major Accelerator Challenges:

- Technologies for Open Strategic Autonomy healthcare, critical raw materials, quantum, space, security etc
- Technologies to address climate change ('Fit for 55') energy, buildings, mobility, land use, green digital, etc



Additional support for scaling up companies

EIC Accelerator call:

- Applicants can apply for **investments above €15 million** if in strategic area, and other sources of funding not available in Europe (Pilot in 2022 limited to 15% of budget)

• EIC Scaleup 100 initiative:

- To identify 100 potential unicorns from EIC portfolio and national schemes
- To support with bespoke mentoring, matchmaking, marketing, etc (Follow up to EIC scalator pilot)

High level expert group on late-stage scaleup financing:

- To assess the case for further actions



Additional support for women innovators

Transition call

- Priority for interview phase for women-led projects (women-led companies or 50% of work package leaders)

Accelerator call

- Broader definition of women-led company (Chief Technology Officer, Chief Scentific Officer as well as CEO)

Pilot European gender and diversity index

- To define and collect comparable data on gender across innovation ecosystem (founders, VCs, investors, etc) and all EU countries
- To publish a pilot gender innovation and diversity index to track progress
- €10 million budget for WomenTech.EU (increased from €4 million in 2021)
 - To support approx. 130 female deeptech founders (€75000 grants)
 - Accompanied by Women Leadership Programme (also to be extended to EIT for mentoring)

- Growing partnerships across the ecosystem: with EIT, with ERC, with national initiatives, etc.


